

ORDINANCE NO. 25 - ____

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR
THE ST. PATRICK'S DAY PARADE AND THE ST. PADDY'S DAY 5K ON
MARCH 15, 2025**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPage AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

SECTION 1: Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the St. Patrick's Day Parade and the St. Paddy's Day 5K from 5 a.m. to 11:30 a.m. on Saturday, March 15, 2025, by adding the underlined language as follows:
