**PETITION FOR ANNEXATION**

TO: Mayor & City Council

THE PETITIONER, Daniel Popiela and Rachel Popiela, having an address located at 2 Carr 459 KM 12.4 Bo Jobos, Isabela, PR 00662, as owner of the approximately 0.35 acres located at 1081 Parkside Road, DuPage County, unincorporated Naperville, Illinois, which property is legally described on **Exhibit A**, attached hereto and made a part hereof (the “Property”), hereby requests that the City of Naperville take the necessary and appropriate action, pursuant to state and local law, to annex the Property to the City of Naperville subject to the terms of a mutually agreeable annexation agreement.

In support of this Petition for Annexation, the undersigned hereby swears to the following under oath and penalty of perjury:

1. Daniel Popiela and Rachel Popiela are the sole owners of the Property legally described on Exhibit A, attached hereto;
2. The Property is unincorporated and is not presently located in the jurisdiction of any other municipality;
3. The Property is contiguous to the City of Naperville, lies within the planning jurisdiction of the City of Naperville and is identified in the City’s Comprehensive Plan for development with the corporate limits of the City of Naperville; and
4. There are no electors residing on the Property.

WHEREFORE, Daniel Popiela and Rachel Popiela hereby respectfully request that the City take such action as necessary and appropriate to annex the Property to the to the City of Naperville subject to the terms of an annexation agreement, which annexation and annexation agreement shall: i) be drawn by and between the City of Naperville and Daniel Popiela and Rachel Popiela; ii) set forth the terms upon which the Property shall be annexed to the City of Naperville; and iii) set forth such other rights and obligations with respect to the Property as the City and Petitioner may mutually agree.
