

ORDINANCE NO. 018 -

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR THE INDIA DAY PARADE AND CELEBRATION ON AUGUST 12, 2018**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS**, in exercise of its home rule authority as follows:

**SECTION 1:** Section VIA, No Parking Zones and Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual are hereby temporarily amended for the India Day Parade and Celebration from 11a.m. to 7p.m. on August 12, 2018 by adding the underlined language as follows:

**SECTION 3:** Section XXVIA, Traffic Prohibited Streets, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the India Day Parade and Celebration from 3:30 p.m. to 7 p.m. on August 12, 2018 by adding the underlined language as follows:
