

ORDINANCE NO. 20 - \_\_\_\_

AN ORDINANCE AMENDING THE NAPERVILLE  
TRAFFIC SCHEDULE TO ESTABLISH  
ONE-WAY AND TWO-WAY STOP CONTROLS ACROSS NAPERVILLE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE,
