The City has an ordinance regulating Kratom. Mayor Wehrli wants Detective Creighton to confirm sales of "Feel Free" are only to people 21 and older.

Commissioner Signorella wants to add Nitrous Oxide as a discussion point,

being an issue in the community.

Mayro Wehrli would like to add a New Business item to the next commission meeting to discuss emerging trends and also discuss the up tick of tobacco fines related to the sale of non-traditional tobacco products.

Commissioner Koranda took the Naperville Liquor Laws Essential class and an online BASSET class and discussed the ease of taking the classes.
