Thank you for all your thoughtful responses. Yes, I'd definitely like to clarify my comments. Our position is as follows:

My comments are in regards to the proposed sidewalk addition in "Page Place" - West St. from Spring Ave to Douglas. Currently proposed for the 2025 project list.


We voted in favor of this sidewalk because:

- 1.) We have two children, ages 6 and 3, and no sidewalk in front or on the side of our house at Spring Ave. We are on an alley so we have no driveway either. We understand we bought the house this way, but having this sidewalk would provide a safe place for our girls (and future residents) to ride their bikes, scooters, etc on our block. Currently they ALWAYS have to cross a street, and despite the stop signs installed at Spring & West, motorists still tend to drive pretty fast around the corner especially when taking the left onto West from Spring. At times, it can be almost dangerous for our family.
- 2.) It connects our house at Spring Ave to the rest of the neighborhood. As I mentioned, we have 1 child that attends Naper School and eventually we will have 2 students. Currently we have to walk down the alley or down the street, because we have no sidewalks. Not only for the walk to school (or the train station for me), but our & our children's friends we are quite isolated despite being in "downtown." Our neighbor to the east rents to college kids, the next house is a halfway house for veterans I believe, and then duplexes. On the other side of West, there are more multifamily rentals (they have a sidewalk), and across from us on Spring Ave. is the Ozinga plant of course, which also happens to have a sidewalk.

I apologize if these comments come too late, but we did have hope we'd be able to make the hearing after our child's curriculum night. As taxpayers, and as community members with growing involvement in the neighborhood, we wanted to make sure we were heard. Especially after a resident made comments that this sidewalk would seem to "serve no purpose," that was repeated by a TAB member. It would absolutely serve a great purpose for our family.

While we do not wish to take away from the mature character of our neighborhoods' landscape it would be nice to have more sidewalk on our corner at Spring & West. The sidewalk absolutely runs unobstructed on our property from Spring Ave, south to the alley that separates our property from the Douglas properties. This sidewalk would greatly improve our way of life on our corner of Naperville. We request that this sidewalk continue to be considered - and offer two suggestions that would may be less impactful to permanent residents and families in our area:

- 1.) Install only half of the proposed sidewalk, From Spring Ave, following West St. south until the alley. (Purple line in picture below)
- 2.) Fill the sidewalk gap on the north end of our block, as it stops halfway between Ewing and West along Spring. I'll add that we'd welcome this project in 2025 or any time earlier. (Orange line in picture)
