

**ORDINANCE NO. 24-\_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 3 (BUSINESS AND LICENSE REGULATIONS),  
CHAPTER 3 (LIQUOR AND TOBACCO CONTROL),  
SECTION 11 (LIQUOR LICENSE AND PERMIT CLASSIFICATIONS)  
OF THE NAPERVILLE MUNICIPAL CODE**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers that:**

**SECTION 1:** Title 3 (Business and License Regulations), Chapter 3 (Liquor and Tobacco Control), Section 11 (Liquor License and Permit Classifications) of the Naperville Municipal Code is hereby amended by adding the underlined language and deleting the stricken language as follows:

**3-3-11: LIQUOR LICENSE AND PERMIT CLASSIFICATIONS:**

The following are classes of liquor licenses and permits with an annual license and permit fee as indicated:

1. On-premises consumption liquor licenses:

**Class A – Restaurant**

	<b>Class B—Restaurant and Tavern</b>
<b>Requirements of Premises</b>	Primary business is the service of meals.
<b>Container Requirements</b>	Liquor by drink, wine by drink not to exceed 9 oz. or wine by bottle/carafe, <u>beer by drink not to exceed 24 oz. except 25 oz. to 32 oz. of draft beer/cider containing not more than 5% alcohol by volume may be sold in a single container with a limit of one per patron per visit,</u> beer or margarita by pitcher not to exceed 60 oz.
<b>Food Requirements</b>	Full menu, including entrees, side dishes, fully staffed kitchen until 9:00 p.m. (Sun.—Thurs.), 10:00 p.m. (Fri.—Sat.)
<b>Liquor Service</b>	No restrictions.

<b>Hourly Restrictions</b>	No liquor service after 11:00 p.m. <u>Serving size of beer/cider is limited to 24 oz. after 10:00 p.m.</u>
<b>Annual Fee</b>	\$2,325.00
<b>Other</b>	Late Night Permit and Growler Permit eligibility.

<b>Requirements of Permit</b>	Class B license holders only.
<b>Consumption</b>	Liquor service from 11:00 p.m. to 1:00 a.m. (Mon.—Fri.), 2:00 a.m. (Sat.—Sun.)
<b>Container Restrictions</b>	<del>None.</del> <u>Serving size of beer/cider is limited to 24 oz. after 10:00 p.m.</u>
<b>Food Service</b>	None.
<b>Type of Liquor Service</b>	Same as with Class B license.
<b>Annual Fee</b>	\$500.00
<b>Other</b>	Cap of 25 for downtown locations, cap of 43 for non-downtown locations.
