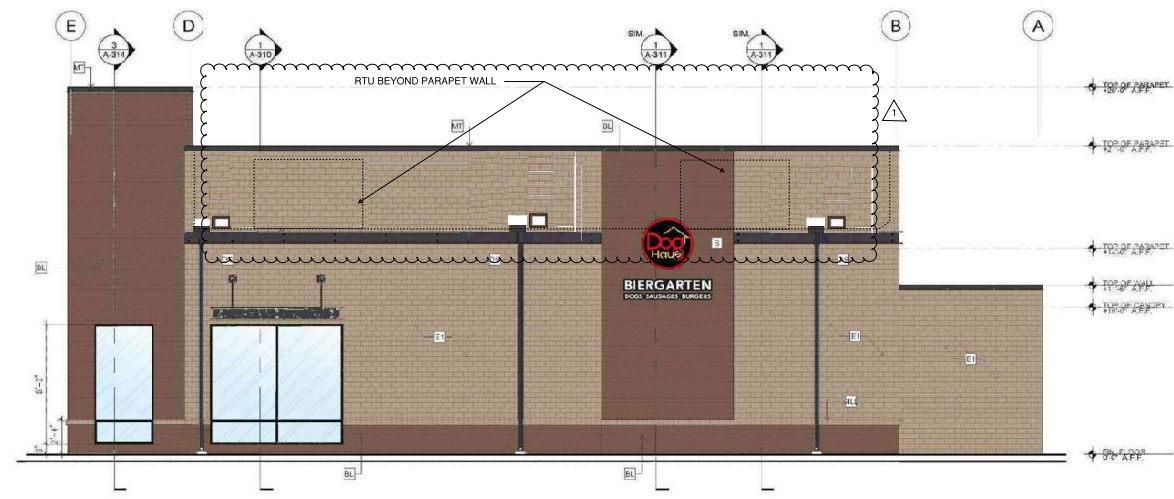




EXTERIOR ELEVATION 1

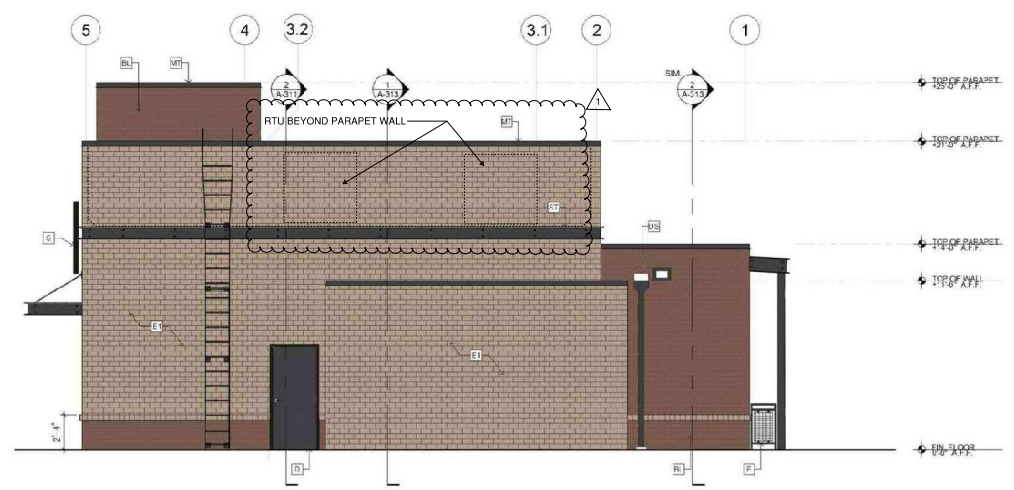

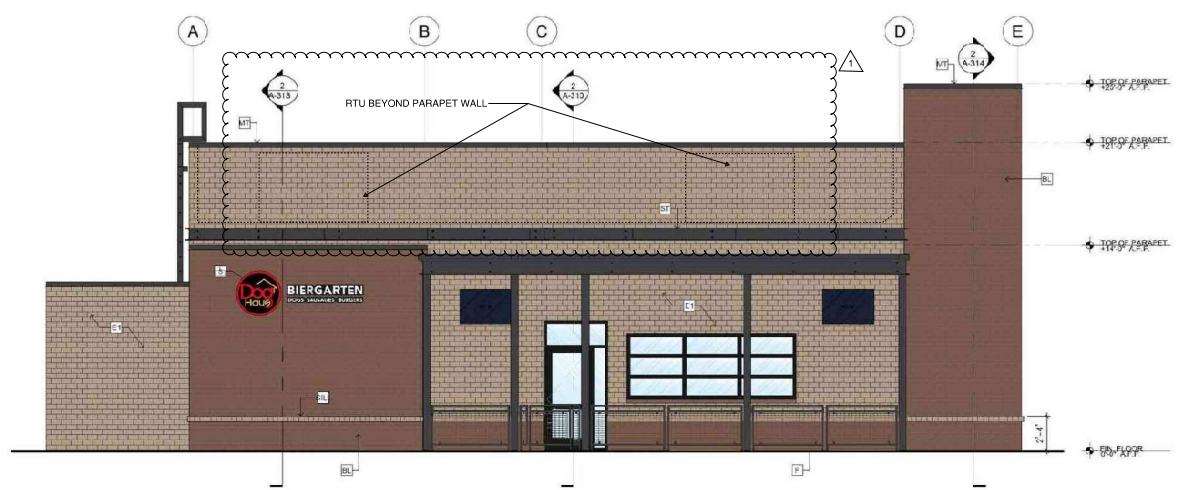

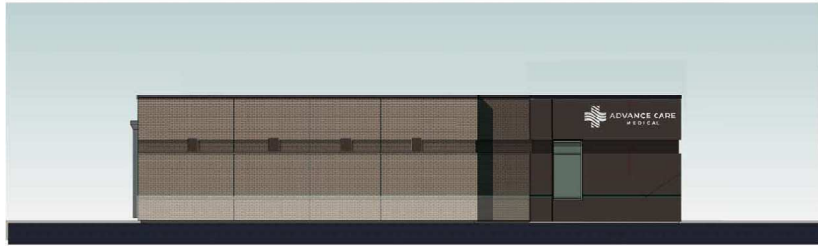
