FOR THE AGREEMENT SIGNAL MAINTENANCE AND ELECTRICAL ENERGY RESPONSIBILITIES FOR CONTROL DEVICES IN THE CITY OF NAPERVILLE

The undersigned DEPARTMENT and GOVERNMENTAL BODY (the PARTIES) agree that the following AMENDMENT shall amend the AGREEMENT referenced herein. All terms and conditions set forth in the original AGREEMENT, not amended herein, shall remain in full force and effect as written. In the event of a conflict, the terms of this AMENDMENT shall prevail. This AMENDMENT is in the best interest of the State of Illinois and is authorized by law and Part 1D. of the AGREEMENT.

1. Description of Agreement

This is the Master Agreement for Local Agency maintenance and apportionment of energy costs for traffic control devices located on State highway within or near the City of Naperville.

2. Effective Date of Amendment

Upon execution until June 30, 2031.

3. Description of Amendment

The DEPARTMENT intend to update the Exhibit "A" of the Intergovernmental Agreement due to revisions of maintenance and energy cost share at traffic signal locations IL Route 59 at 111th, IL Route 59 at McCoy and IL Route 59 at Champion Rd described within.

The State of Illinois, acting by and through its Department of Transportation (hereinafter referred to as the "Department") and the City of Naperville (hereinafter referred to as the "City") entered into an Intergovernmental Agreement with the State for traffic signal maintenance and electrical energy responsibilities dated 12/22/2021.

IL Rte 59 at 111th St (TS21860), per to Highway Permit 1-T-10-0081, maintenance cost share to the Departments responsibility requires revision.

IL Rte 59 at Champion Rd (TS21866), per to Contract 62K28, will be added to the City's Exhibit A.

IL Rte 59 at McCoy/Fox River Commons (TS6089), the City does not have responsibility and will be remove from the City's Exhibit A.

The above mentioned intersections will be revised as follow to reflect and comply with its respective executed agreement and/or permit:

Traffic signal IL Rte 59 at 111th St maintenance cost share splits will be revised as shown below:

FROM: Maintenance responsibility = 100% State, 0% City of Naperville

TO: Maintenance responsibility = 75% State, 25% City of Naperville

Traffic signal IL Rte 59 at Champion Rd will be added as outlined below:

Maintenance responsibility = 50% State, 25% Plainfield, 25% City of Naperville

Energy responsibility = 50% State, 25% Plainfield, 25% City of Naperville

Traffic signal IL Rte 59 at McCoy/Fox River Commons - REMOVED

All terms and conditions stated in this Amendment shall be made a part of the Original Intergovernmental Agreement executed between the City of Naperville and the State for the term of which began on July 1, 2021, and that all other terms and conditions not in conflict with this Amendment as enumerated in that Original Master Intergovernmental Agreement remain applicable.

A provision to the City's energy cost share responsibility at the mentioned intersection is indicated in Attachment B, Revised Exhibit A dated 11/01/24.
