I am in a golf league at Naperbrook, use doctors at the Edward Hospital branch on 127th, visit the Massage Envy at 135th and Route 59, and take my grandchildren to the beautiful Naperville park at Wolf's Crossing. This narrow two lane road running through various neighborhoods is ALWAYS busy with bikers, runners, dog walkers, walkers, and vehicles of neighboring residents who use this road for work and pleasure.

Please reconsider allowing the building of the large Islamic **Center** (gym, huge parking lot, and convention space) in the proposed site on 248th.
