# PETITION TO THE NAPERVILLE CITY COUNCIL FOR VARIANCE APPROVAL

THE UNDERSIGNED Petitioner, ZSRM, Inc ("Petitioner"), respectfully petitions the City of Naperville to approve a variance to Section 3-3-11 of the City's Municipal Code to operate a Class C – Tavern liquor license on the property located at 634 E. Ogden Avenue (the "Subject Property") pursuant to the appropriate provisions of the Naperville Municipal Code, as amended (the "Municipal Code").

# **BACKGROUND INFORMATION**

- 1. Petitioner, will be the tenant of the Subject Property.
- 2. The owner of the Subject Property is KG Properties (the "Owner").
- 3. The Subject Property consists of approximately 3,000 square feet located at 634 E Ogden Avenue, Naperville at the address commonly known as Miss Kitty's Saloon.
- 4. The Subject Property has been occupied by a Tavern since 1974.
- 5. Petitioner desires to continue to operate a tavern on the Subject Property consistent with past uses.

# VARIANCE TO PERMIT A CLASS C TAVERN LICENSE IN A SHOPPING CENTER THAT IS LESS THAN 60,000 SQUARE FEET

The requested variance meets the requirements under Naperville Municipal Code and is appropriate based upon the following factors:

1. The variance is in harmony with the general purpose and intent of the Liquor Control Ordinance and the variance is not precedent setting; and

The variance is in harmony with the intent of the Liquor Control Ordinance and is not precedent setting. A tavern has existed on the Subject Property for almost 50 years. The variance request is to continue the use which has long existed on the Subject Property and the use predates the current requirement of a shopping center that exceeds 60,000. Accordingly, the variance request is not precedent setting and may be considered legally non-conforming.

2. Strict enforcement of the Liquor Control Ordinances would result in practical difficulties due to special and/or unusual circumstances surrounding the property and circumstances substantially outside the petitioner's control; and.

Strict enforcement of the code section requiring a center with over 60,000 square feet would result in the Subject Property no longer being used as a tavern which has existed for almost 50 years. The special circumstances in that the liquor control requirement of 60,000 square feet was codified long after the tavern existed on the Subject Property. This requirement is out of both the building Owner and tenant's control.

3. The variance, if granted, will not alter the essential character of the liquor establishment or underlying liquor license requirements and will not be a substantial detriment to adjacent property.

The variance will not alter the essential character of the liquor establishment or be a substantial detriment to the adjacent property. The tavern has existed on the Subject Property for almost 50 years and is a continuation of a use that existed before the 60,000 square foot code requirement was even put into effect. Additionally, the surrounding area is predominantly commercial in nature and will not be negatively impacted by the continuation of the existing use.

**WHEREFORE**, by reason of the foregoing, the undersigned Petitioner requests the City Council approve a variance to permit the Petitioner to operate a Class C – Tavern liquor license

on the Subject Property pursuant to the appropriate provisions of the Naperville Municipal Code, as amended (the "Municipal Code").


