

**ORDINANCE NO. 18-\_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 3 (BUSINESS AND LICENSE REGULATIONS),  
CHAPTER 3 (LIQUOR AND TOBACCO CONTROL),  
SECTION 11 (LIQUOR LICENSE AND PERMIT CLASSIFICATIONS)  
OF THE NAPERVILLE MUNICIPAL CODE**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers that:**

**SECTION 1:** Title 3 (Business and License Regulations), Chapter 3 (Liquor and Tobacco Control), Section 11 (Liquor License and Permit Classifications) of the Naperville Municipal Code is hereby amended by adding the underlined language as follows:

**3-3-11: LIQUOR LICENSE AND PERMIT CLASSIFICATIONS:**

The following are classes of liquor licenses and permits with an annual license and permit fee as indicated:

1. On-premises consumption liquor licenses:

**Class A – Restaurant through Class K – Catering \* \* \***

	<b>Class M – Recreational</b>
<b>Requirements of Premises</b>	Service of liquor only during the time that the recreational portion of premises is open and available for use or with a paid lifestyle amenities service. For golf courses, liquor may be served outside the physical structure but must be adjacent to and within the property lines of golf course.
<b>Container Requirements</b>	Liquor by drink, wine by bottle/carafe, beer by pitcher not to exceed 60 oz. or by bottle not to exceed 16 oz. For lifestyle amenities facilities, wine by the drink not to exceed 6 oz. or beer by the drink not to exceed 12 oz., two drinks total per patron.
<b>Food Requirements</b>	May be served as long as it complies with all health regulations and licensing requirements.
<b>Liquor Service</b>	No outside liquor.

<b>Hourly Restrictions</b>	During recreational activity only or with paid lifestyle amenities service.
<b>Annual Fee</b>	\$2,200.00
<b>Other</b>	Cap of 42 <u>13</u> . Certified record of annual revenue shall be included with renewal paperwork for review by the Liquor Commissioner. Insurance required for outside premises.

2. Off-Premises Consumption Liquor Licenses:

**Class D – Package Store**

	<b>Class G – Beer and Wine Package Sale</b>
<b>Requirements of Premises</b>	Must be located in a <u>shopping center</u> containing not less than 60,000 sq. ft. <u>square feet of gross building floor area</u> , or a B1 zoned property containing at least 45,000 sq. ft. <u>square feet of gross building floor area</u> .
<b>Consumption</b>	Off-premises only
<b>Container Requirements</b>	Sale in original package.
<b>Liquor Tasting</b>	1/month for no greater than 3 consecutive days (\$100/yr.) or weekly for no greater than 2 consecutive days (\$200/yr.)
<b>Annual Fee</b>	\$1,700.00
<b>Other</b>	Capped at <del>64</del> . <u>Square footage requirements are not applicable to renewal of existing Class G licenses.</u>
