John Beckman presented for Tasting Devine Cellars. They are requesting a fee reduction for the S1, Specialty Wine Shop with specialty liquor. The current fee is \$3,600. Commissioner Douglas recommended a fee reduction to

\$1,650, seconded by Commissioner Chirico. The liquor commission has recommended a reduction, this will appear on a future City Council agenda for their consideration.

Piccolo Buco, 404 S. RT 59

Like Cooper's Hawk, Piccolo Buco is a full-service restaurant serving and selling beer, wine and spirits in a 200+ seat restaurant. Seeking a Class B and Class S liquor license. Their request is in process.

Draft Picks, 523 Fairway Dr.

Existing Class B license, new ownership. Their request is in process.
