Dear Mayor Wehrli and Members of City Council,

We are writing in regard to Item **25-0714** on the June 17 City Council agenda item, concerning the "First Reading of the Naperville Municipal Code to establish Municipal Grocery Taxes" as a replacement for the 1% state grocery tax.

The board of the Downtown Naperville Alliance - comprised of downtown property owners, business owners, and designated members - discussed this topic at our recent meeting. Following the meeting, a strong majority of the board, via electronic vote, expressed support for enacting a local 1% grocery tax. Most felt this would serve as a straightforward continuation of the existing tax and maintain alignment with other suburban municipalities.

However, the group does **not** support increasing the Home Rules Sales tax as a means of offsetting the grocery tax shortfall. There was strong concern that such an increase would place an added burden on our retailers and restaurants, especially in today's challenging economic climate. Additionally, higher sales taxes could lead to increased credit card processing fees for these businesses – at a time when profit margins are already under significant pressure.

We appreciate your thoughtful consideration of this important matter and thank you for your continued leadership in maintaining Naperville as a safe, welcoming, and well-regulated community.
