This is a franchise that will be the 3rd location in Illinois; there are 65 in the nation. This is a painting studio that specializes in pouring acrylic paint, they will also have a space for other artists to come in and teach/display their crafts.

The Commissioners reinforced BASSET requirements for all staff. There will not be outdoor classes taught, all liquor will be limited to inside the facility.

Commissioners researched other Hawaii Fluid Art locations and did not find any complaints or issues.

There are currently no Class M Recreational licenses available, a license cap increase is being referred to the City Council at the next available meeting in October.
