**ORDINANCE NO. 25-\_\_\_\_\_**

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES  
FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2026, AND ENDING  
DECEMBER 31, 2026, IN AND FOR THE CITY OF NAPERVILLE  
SPECIAL SERVICE AREA NO. 23 (NAPER MAIN)**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE,  
DUPAGE AND WILL COUNTIES, ILLINOIS,** in exercise of its home rule authority, as  
follows:

**SECTION 1:** The City of Naperville Special Service Area No. 23 has been created  
by Ordinance No. 07-196, entitled, "An Ordinance Establishing City of Naperville Special  
Service Area Number Twenty-Three (Naper Main)," passed on August 21, 2007, and  
effective as of August 22, 2007. Said Special Service Area No. 23 consists of the territory  
described in Ordinance No. 07-196, as amended from time to time. The City of Naperville  
is now authorized to levy taxes for payment of expenditures therein for improvements  
described in the aforesaid ordinance.

**SECTION 2:** That the total amount of expenditures for all purposes to be collected  
from the tax levy of the current fiscal year in Special Service Area No. 23 is ascertained  
to be \$98,939.

**SECTION 3:** A sum sufficient to provide \$98,939 is hereby levied upon the taxable property, as defined in the Revenue Act of 1939, in the City of Naperville Special Service Area No. 23, said tax to be levied for the fiscal year beginning January 1, 2026, and ending December 31, 2026.

**SECTION 4:** The tax levied by this ordinance is pursuant to Article 7 of the Constitution of the State of Illinois and pursuant to 35 ILCS 200/27-5, as amended from time to time, and pursuant to an ordinance establishing City of Naperville Special Service Area No. 23.

**SECTION 5:** There is hereby certified to the County Clerk of DuPage County, Illinois, the sum of \$98,939, which said total amount the City of Naperville Special Service Area No. 23, requires to be raised by taxation for the current fiscal year of said City, and the City Clerk is hereby directed to file with the County Clerk of said County a certified copy of the ordinance.

**SECTION 6:** This ordinance shall be in full force and effect upon its passage and approval.
