Please let this letter serve as a Request for Appeal from Little Friends, Inc. of the October 24, 2019 Historic Preservation Commission denial of their request for issuance of a Certificate of Appropriateness to demolish the building as requested in HPC Case No. 19-2840.

Let this letter also serve as a simultaneous appeal from the Historic Preservation Commission denial of the Certificate of Appropriateness to demolish that portion of the building identified in the Commission deliberation as the Kroehler mansion located on 126 North Wright Street, Naperville, Illinois 60540, the legal description and permanent index number of the lot on which the mansion sits is:

The South 260.10 feet of the East 187.00 feet, as measured on the East and South lines, of Block 2 in Kroehler's Addition to Naperville being a Subdivision in Section 18, Township 38 North, Range 10, East of the Third Principal Meridian in DuPage County, Illinois, according to the Plat recorded May 14, 1906 as Document No. 87553, n DuPage County, Illinois.
