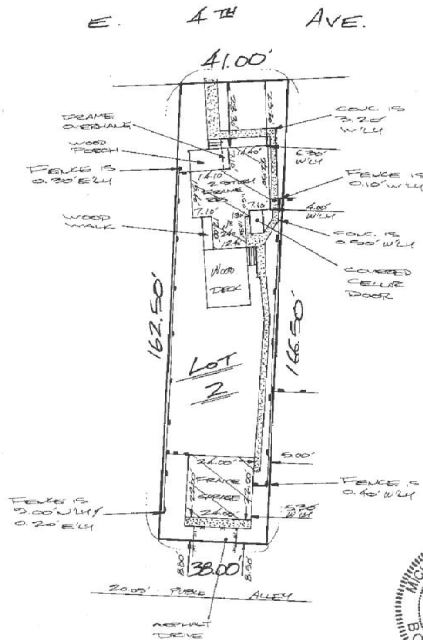

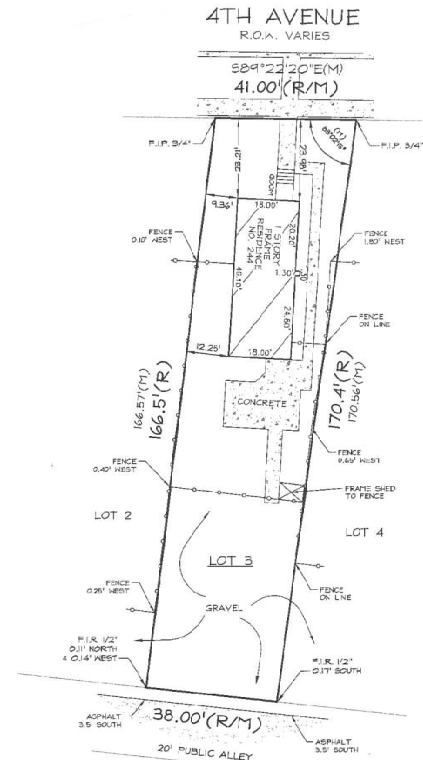


BASIS OF BEARING:
