## ORDINANCE NO. 23 - \_\_\_

## AN ORDINANCE AMENDING THE NAPERVILLE TRAFFIC SCHEDULE TO UPDATE SCHEDULE V, TRUCK ROUTES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, ILLINOIS, DuPAGE AND WILL COUNTIES, in exercise of its home rule authority as follows:

**SECTION 1**: Schedule V, Truck Routes, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language and by adding the underlined language as follows:
