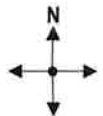

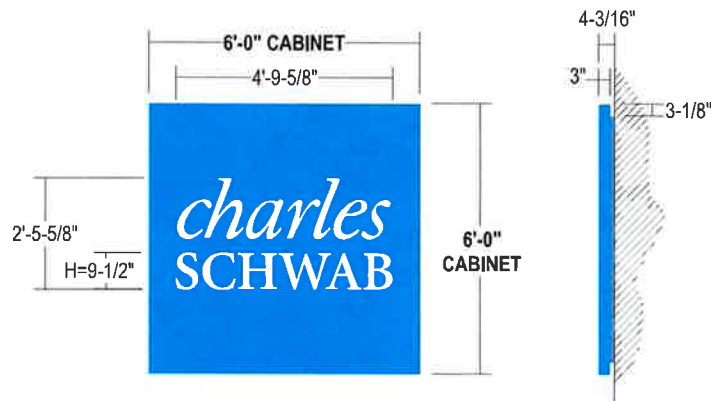

FACES: .125" routed aluminum painted core blue, with 3/4" clear acrylic, pocket-routed push-thru acrylic (1/2" exposed), and decorated with white translucent vinyl to surface. Faces attached to 2"x4" alum. channel frame painted core blue

RETURNS: 3-7/8" deep .125" aluminum returns painted core blue attached to face with 3"x1-3/4"x1" breakform alum. angle and countersunk; interiors painted white

BACKS: 1" x 1" aluminum tube support

ILLUM.: GEMM2471-W1 (miniMax 71k-24v) White LED as required by manufacturer; Include perimeter White LEDs mounted to angle
Remote Power Supplies

BLOCKING: GC to provide 12" blocking on all sides behind signage

INSTALL: Thru bolted with 1/2" stand-off from wall surface using all thread into approved blocking. 12" standard length of min 3/8" threaded rod will be supplied unless otherwise noted;

SIMULATED NIGHT VIEW

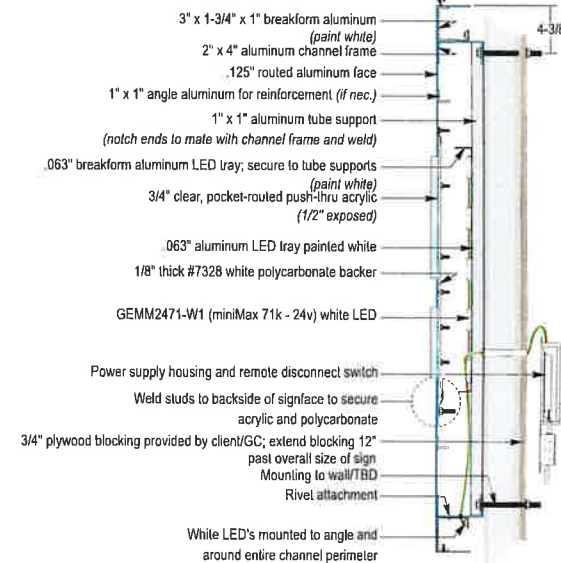
