

ORDINANCE NO. 26 - ____

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR
THE NAPERVILLE WOMEN'S HALF MARATHON AND 5K RUN –
SUNDAY, APRIL 19, 2026**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE,
DuPage AND WILL COUNTIES, ILLINOIS,** in exercise of its home rule authority as follows:
