

ORDINANCE NO. 023 -

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR
THE G.L.O.W. RUN 5K ON MAY 20, 2023**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

SECTION 1: Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the G.L.O.W. Run 5K from 4 p.m. to 10 p.m. on May 20, 2023 by adding the underlined language as follows:

SECTION 2: Section VIA, No Parking Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the G.L.O.W. Run 5K from 4 p.m. to 10 p.m. on May 20, 2023 by adding the underlined language as follows:
