I have received the Notice for Public Hearing and I would like to hereby voice my concerns for the action proposed: to allow major change of zoning to the Iroquois PUD.

As a resident of the Mansions on Spring Garden Circle, I have several worthy concerns.

Our once residential street, Iroquois Ave, has become a major thoroughfare to allow traffic for Costco. If a restaurant like Chik-fil-a opens up, the already narrow lane between the two signs will make the traffic horrendous. As it stands right now, trying to make a turn from Iroquois onto Ogden is very difficult. There is no green arrow to allow for a left turn. Often, we have to wait for several lights in order to turn left. Having the added traffic will make things worse. Already, several accidents have happened in that intersection.

Another concern is for the danger it will represent for those disabled folks who live in the facility *Katharin Manor Apartments*, next to the Costo gas station. Often they are seen in their motorized wheelchairs trying to go someplace. The high traffic and the narrowing of the road will likely limit their foray options and put them in danger.

Another concern is what one more restaurant, so close to a residential area will do for the air quality. Already the air smells bad from the five other restaurants within a block of the proposed site.

I am urging you to reconsider the plan of allowing another fast food restaurant so close to our residential area.

I wanted to write to the PZC on behalf of the vast, and largely silent, majority of residents who support developments like this and do not express their views in favor.

It appears the arguments against this project amount to impacts to traffic on Iroquois Avenue. Based on the site plan and all other backup materials, there does not appear to be any direct connection from the subject property to Iroquois Avenue. Using Iroquois Avenue to access the Iroquois Center and ultimately the Chick Fil A site would not be a logical path of travel for any vehicles coming from either direction on Ogden. The traffic study submitted by the Applicant supports this. As such, granting this PUD Amendment will have no demonstrable impact to traffic on Iroquois Avenue.

The proposed improvements are in line with the City's stated goals in the Ogden Avenue Enhancement Initiative. The proposal also reflects a modernization and much needed aesthetic improvement to the Iroquois Center itself.
