## **ORDINANCE NO. 022 -**

## AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR THE G.L.O.W. RUN 5K ON MAY 21, 2022

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

**SECTION 1**: Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the G.L.O.W. Run 5K from 4 p.m. to 10 p.m. on May 21, 2022 by adding the underlined language as follows:
