

RESOLUTION NO. 17 - ____

A RESOLUTION EXPANDING THE RIVERWALK BOUNDARY

WHEREAS, the City of Naperville (“City”) and the Naperville Park District (“Park District”) have worked cooperatively, in conjunction with the Naperville Riverwalk Commission, to construct and improve the Naperville Riverwalk, and to that end have entered into an intergovernmental lease agreement (hereinafter “Intergovernmental Agreement”) as amended from time to time; and

WHEREAS, Exhibit 1 to the Intergovernmental Agreement depicted the territory of the Naperville Riverwalk which was subject to the Agreement prior to April 18, 2017; and

WHEREAS, on April 18, 2017 the Intergovernmental Agreement was amended to include the Water Street Riverwalk Improvements and Exhibit 1 to the Agreement was amended by Addendum 1 depicting the Water Street Riverwalk expansion; and

WHEREAS, a revised Exhibit 1 to the Intergovernmental Agreement (hereinafter “Exhibit 1-2017”) is attached hereto and made part hereof which includes the Water Street Riverwalk expansion; and

WHEREAS, the City and the Park District wish to further expand the boundaries of the Naperville Riverwalk to encompass property located between the Naperville Municipal Center and the West Branch of the DuPage River as noted on Exhibit 1-2017, which property is currently landscaped but used for no other purpose (hereinafter “Municipal Center Expansion Property”); and

WHEREAS, the Park District shall not be responsible for operation or maintenance of the Municipal Center Expansion Property and therefore no adjustment to the amount of City contributions under the Intergovernmental Agreement needs to be made; and

WHEREAS, Exhibit 1-2017 also depicts anticipated expansion of the Naperville Riverwalk which may occur in the future; and

WHEREAS, the Intergovernmental Agreement is due to expire on December 31, 2018 at which time it is anticipated that the Agreement will be renewed subject to any needed revisions and updates.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, COUNTIES OF DUPAGE AND WILL, ILLINOIS, in exercise of its home rule authority, as follows:

SECTION 1: The foregoing Recitals are set forth in this Section 1 as though fully set forth in this Section 1.

SECTION 2: Exhibit 1 of the Intergovernmental Agreement with the Naperville Park District regarding the Naperville Riverwalk is replaced by Exhibit 1-2017 attached hereto and made part hereof; and

SECTION 3: The boundary of the Naperville Riverwalk is expanded to include the Municipal Center Expansion Property depicted on Exhibit 1-2017.

SECTION 3: This Resolution shall be in full force and effect upon its passage and approval.
