

**RESOLUTION NO. 25-\_\_\_\_**

**RESOLUTION OF THE CITY OF NAPERVILLE, ILLINOIS DECLARING ITS  
OFFICIAL INTENT TO REIMBURSE CERTAIN CAPITAL EXPENDITURES  
FROM THE PROCEEDS OF FUTURE DEBT ISSUES**

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF  
THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS**, in exercise  
of its home rule powers, as follows:

**SECTION 1.** The purpose of this resolution is to satisfy the “Official Intent  
Requirement” of Treasury Regulations Section 1.150-2.

**SECTION 2.** The City of Naperville, Illinois (the “City”) has determined to undertake  
the following capital improvement projects, at an estimated aggregate cost of  
\$53,900,000 and to expend funds to pay costs of such capital improvement projects.

<b><u>Project</u></b>	<b><u>Estimated Costs</u></b>
<b>Right-of-Way Improvements</b> Projects include road construction and re-construction; bridge construction and rehabilitation; sidewalk and other pedestrian updates.	<b>\$2,300,000</b>
<b>Buildings &amp; Facilities</b> Projects include the replacement, maintenance, or renovation of public owned facilities.	<b>\$2,700,000</b>
<b>Technology</b> Projects include the replacement of technology hardware and software systems.	<b>\$10,000,000</b>
<b>Utility Infrastructure</b> Projects include infrastructure maintenance and improvements, including water main replacements, wastewater treatment plant upgrades, electric substation improvements, and cable replacements.	<b>\$38,900,000</b>

**SECTION 3.** The City reasonably expects to be reimbursed for such expenditures  
with proceeds of its debt. The maximum principal amount of debt expected to be issued  
for the reimbursement of such expenditures is \$53,900,000.

**SECTION 4.** This declaration of official intent is consistent with the budgetary and financial circumstances of the City.

**SECTION 5.** A copy of this resolution shall be filed immediately in the office of the City Clerk and shall be made available for public inspection in the manner required by law.

**SECTION 6.** This resolution shall be operative and effective upon its passage.
