EXHIBIT 1: Section 6-3-8:2: Standards for Granting or Amending a Conditional Use

1. The establishment, maintenance or operation of the conditional use will not be detrimental to, or endanger the public health, safety and general welfare;

RESPONSE:

Eris Qesari, a Naperville resident, and U.S. citizen, currently owns and operates a successful, upscale, luxury tattoo studio in Oak Park, called Venture Tattoo Studio Inc. He intends to purchase 424 Fort Hill Drive, #142, in B3 zoning, on April 16, 2024, on behalf of the business, VTS Proprieties LLC. This business, which is located in Fort Hill Business Center, is intended for a second location, closer to his home and family, where he can provide an elegant, spa-like experience to the most discerning clientele by appointment. There is a need for this business, as there are no other body art studios in Naperville, nor nearby surrounding areas. There is appropriateness, due to the nature of both the art and the clientele, (which includes police officers, fire fighters, military heroes, professional athletes, and notable public figures, seeking Qesari's unique artistic talent in a private, upscale setting).

Public health and safety are the utmost concern. As an example, Qesari's first studio location was selected by the Oak Park Department of Public Health to record a You Tube video on studio cleanliness, regulation compliance, and overall cooperation with the Village of Oak Park. 2. The conditional use will not be injurious to the use and enjoyment of other property in the immediate area for the purposes already permitted, nor substantially diminish and impair property values within the neighborhood;

RESPONSE:

Following Naperville's municipal code requirements for this type of body art business, the location is correctly zoned B3, in the Fort Hill Business Center. The purpose of this business is to invite clients by appointment to a private, indoor, relaxing spa-like setting. Most of the clients are police officers, fire fighters, military heroes, professional athletes, and other celebrities who are seeking this type of private, upscale environment. This location is ideal for both the studio and its business neighbors. The studio is intended to be to provide upscale service to private clients by appointment, thus creating low-traffic with minimal parking needs. Signage will appropriate, to code, and would not impede neighboring businesses. The nature of this business, its cleanliness and its clientele are anticipated to elevate area property values, and in no way dimmish or impair them.

 The establishment of the conditional use will not impede the normal and orderly development and improvement of the adjacent property for uses permitted in the district; and

RESPONSE:

By nature of the City of Naperville's municipal code requiring body art studios to require conditional use in B3 zone, this is the perfect fit for both Venture Tatoo Studio and the Fort Hill Business Center neighbors. The clients of this business want private settings, indoors, with a luxury upscale environment. This location will be by appointment, with no retail or walk-in public traffic. Therefore, both the studio clients and the neighboring businesses will co-exist harmoniously; this is a low-traffic situation requiring minimal parking.

Eris Qesari is a highly sought-after artist, with over 32.4k followers on Instagram, @erisqesari. While although has earned multiple top awards within the tattoo industry, his paintings and drawings prove him to be an accomplished artist across multiple media. His piece, titled "I Love You," was selected by the Oak Parks Art District to hang on banners throughout the City of Oak Park.
