DiSanto discussed establishing objective criteria for the Council to apply in order to staff to start the landmarking process, that after Council direction the request will go before the Historic Preservation Commission ("Commission") for review and public hearing, and the last step will be for the City Council to vote on the Commission recommendation.

Laff explained recent landmark surveys.

Council stated that landmarking qualifications/criteria should be determined prior to any Council deliberation.

DiSanto explained that two commissions will review the draft landmarking text amendment prior to Council consideration.
