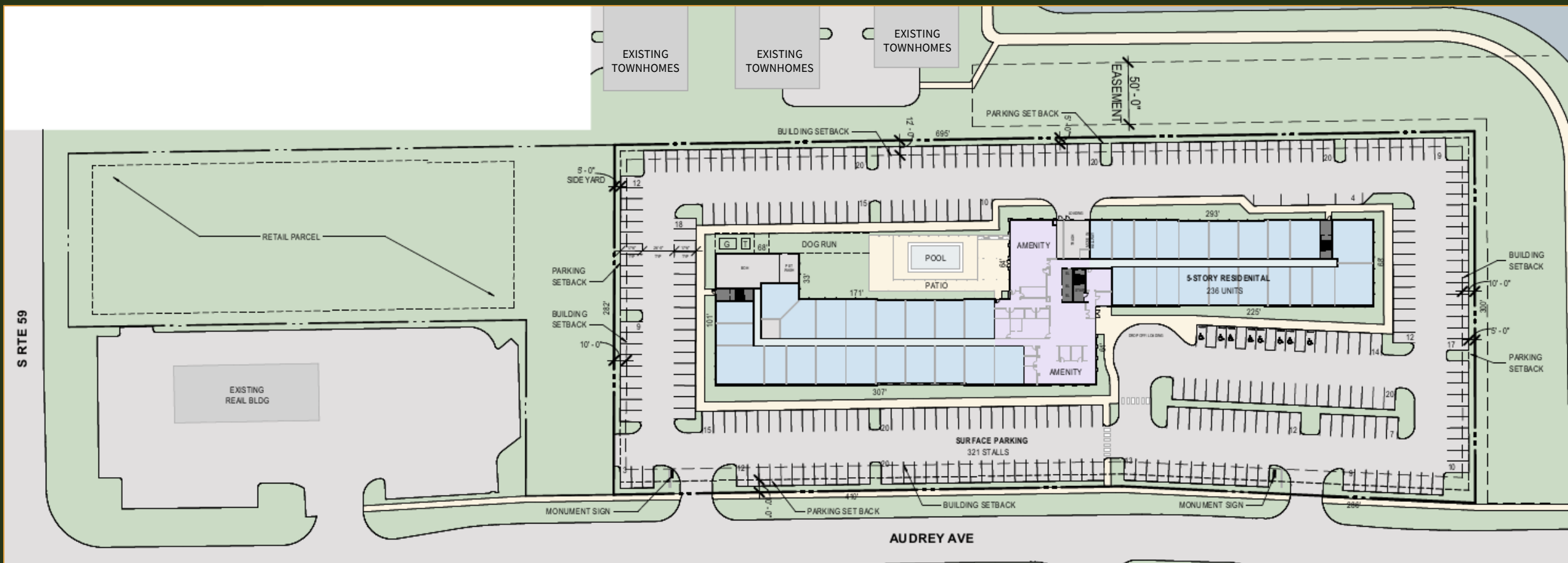

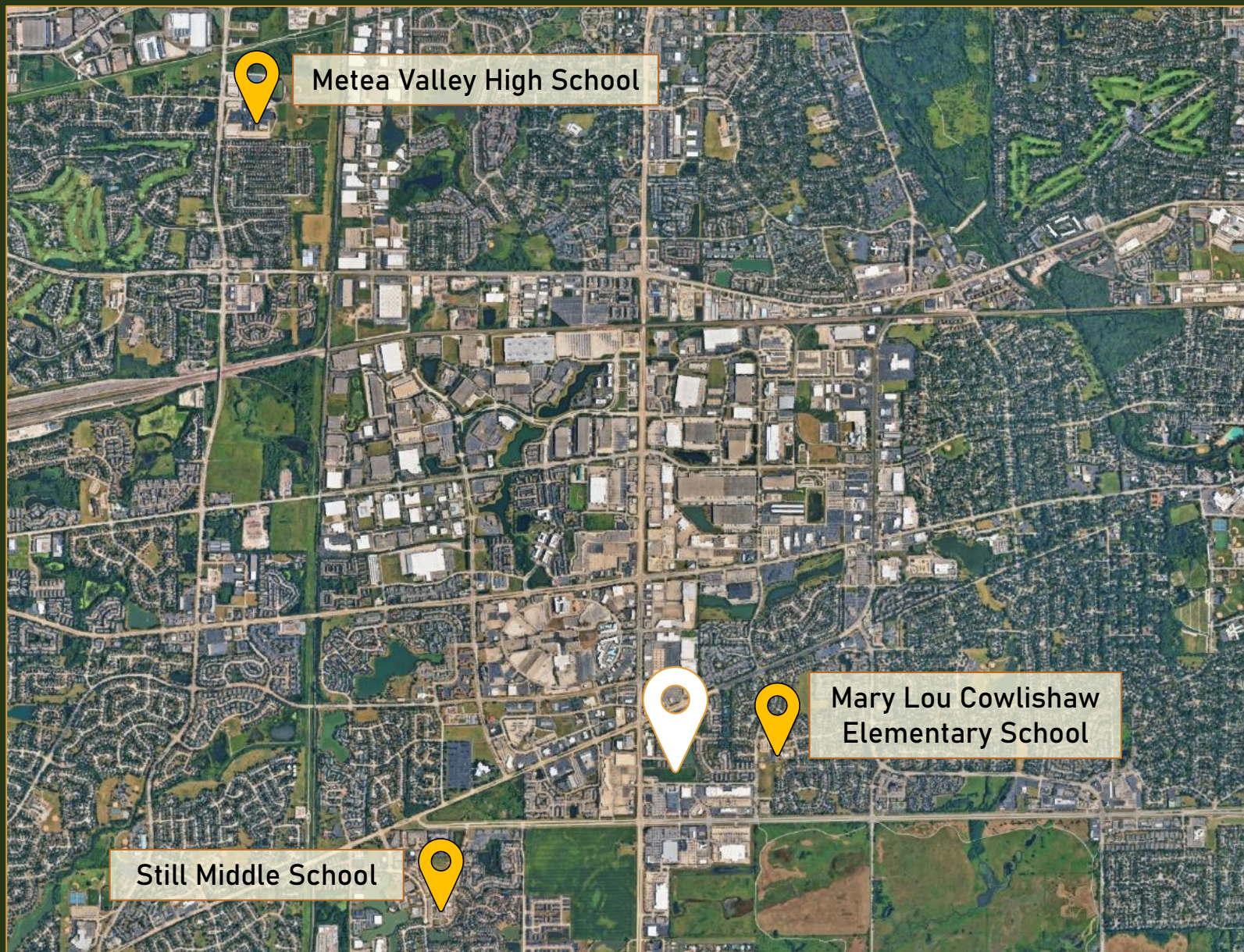

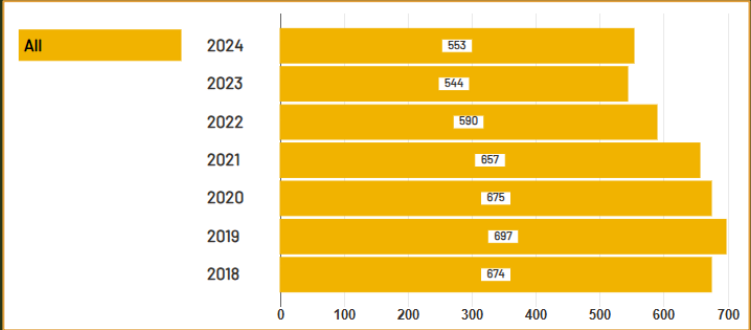
ANTICIPATED VS ACTUAL



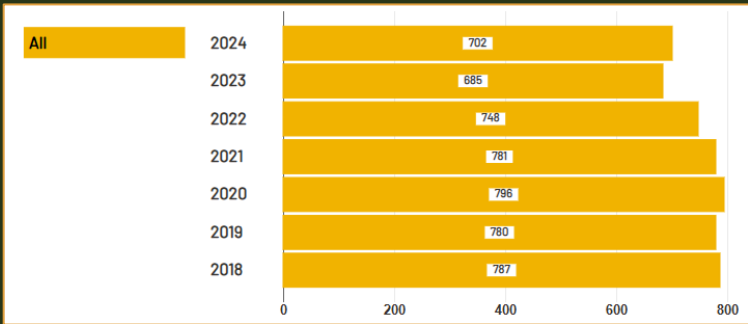

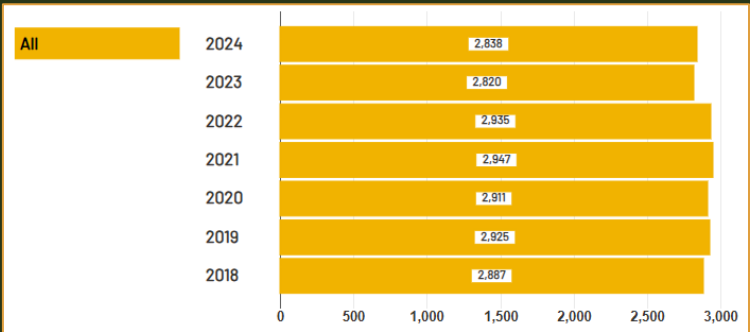
