Pure Barre is a fitness franchise under the Xponential Fitness umbrella with nearly 600 Pure Barre studios globally. When Pure Barre Naperville opened in 2014 a variance was provided due to Pure Barre's retail business. Pure Barre Naperville was originally located at 143 W Jefferson Ave on the corner of Jefferson and Webster.

When I purchased the business in 2017, the Pure Barre owner had been discussing a move to the second floor with landlord Steve Rubin. Shortly after I closed on the business in June 2017, we transitioned to a new space at 130 W Jefferson Ave Ste 212.

One year into the move we quickly grew and completed a second round of construction. With the closing of both Dailey Method and Bar Method, our closest barre competitors, and with my upcoming lease expiration, I have been exploring new spaces that will allow us to continue to grow.

I'm most interested in first floor spaces due to our growing retail business. During Covid, when fitness studios closed for nearly 4 months and we experienced significant client attrition, we relied on our retail business heavily. We used social media and a private Facebook page to sell athleisure wear to our clients and our social media followers. We are excited to continue to grow this piece of our business - especially since we carry products that are not carried anywhere else in downtown Naperville.

Through Pure Barre, we have exclusive rights to many styles that other businesses (like Dick's Sporting Goods) do not have access to. Our top selling brands include Strut This, Onzie, Spiritual Gangster, Free People, Varley, Emily Hsu - to name a few. We believe that our products will compliment the needs of those who currently shop at Evereve, Anthropologie and Lululemon. Our clients shop at all of these stores today and being located conveniently near them will draw more business to these stores that I personally also enjoy. In our current location we partner with several nearby business in downtown Naperville and my hope is that we can continue to support these business while forging new relationships.

The thought of having a true, first floor retail business is so exciting for me and my staff. Just before Covid we grew our member base by 400% and things are picking back up for us. We need a larger studio space to continue to grow and a first floor space to take our retail goals to the next level.
