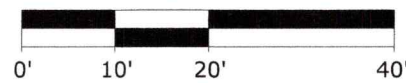


BASIS OF BEARING

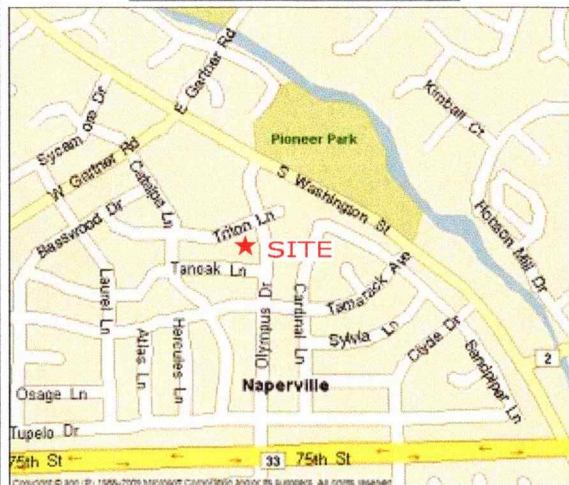
BEARINGS SHOWN HEREON ARE BASED ON ILLINOIS STATE PLANE, EAST ZONE, NAD83 (2011)

LOCATION MAP

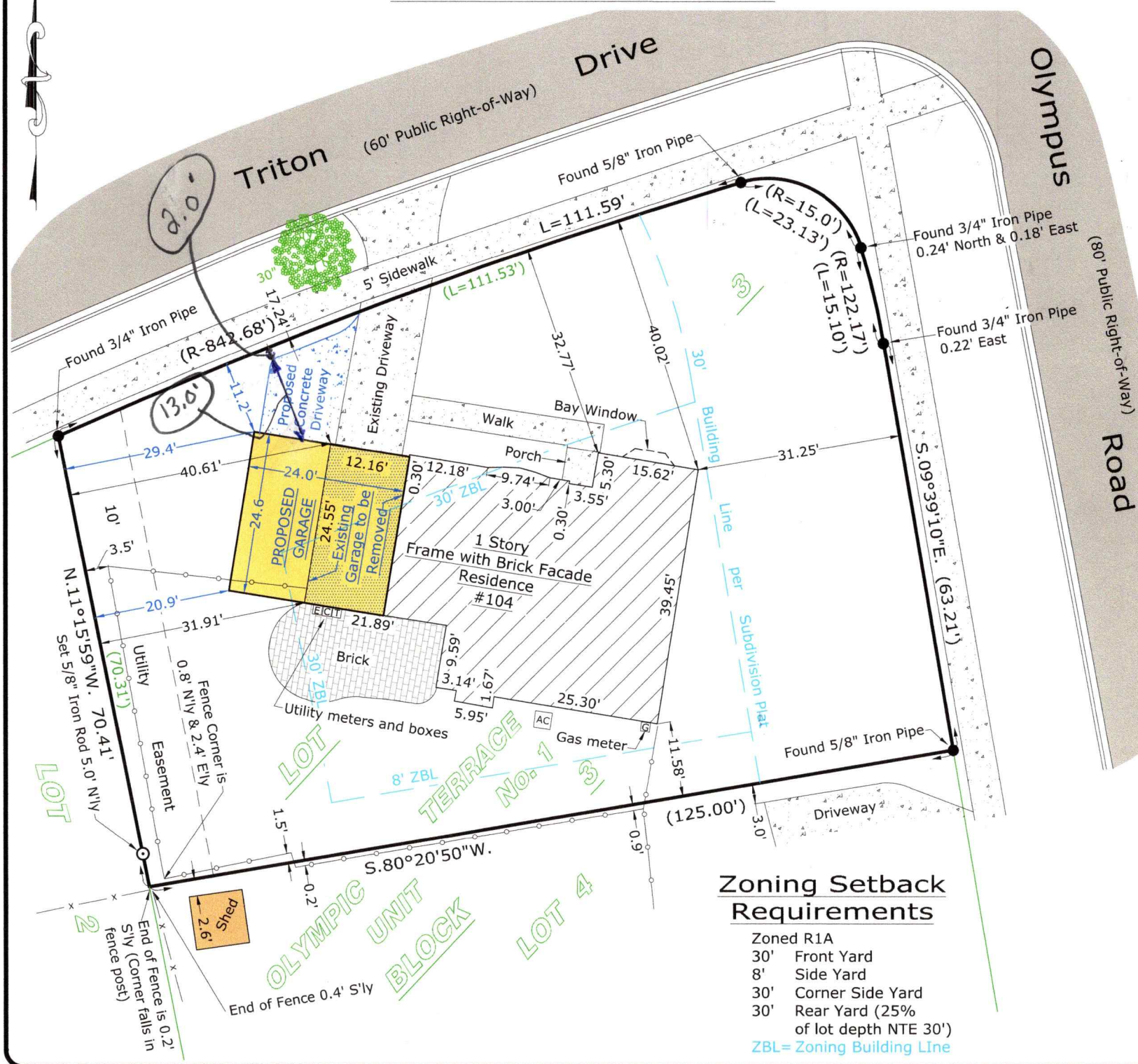

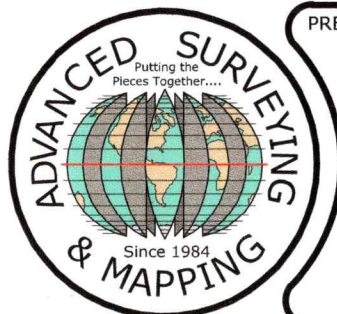
