

ORDINANCE NO. 018-

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR
THE NAPERVILLE HALF MARATHON AND 5K RUN –
SUNDAY, OCTOBER 21, 2018**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

SECTION 1: Section VIA, No Parking and Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the Naperville Half Marathon and 5K Run from 5 a.m. to 12 p.m. on Sunday, October 21, 2018 by adding the underlined language as follows:
