- ▶ The City Council directed staff and the Commission to review the SECA Grant Fund Program and present recommendations for change.


WHERE HAVE WE BEEN? JANUARY 2016

- ▶ Confirm roles of Advisory Cultural Commission and City Council
- ▶ Confirm eligibility criteria to apply for SECA funding
- ▶ Confirm changing SECA Fund cycle to calendar year in 2017
 - ▶ May 2016-April 2017 (FY17)
 - ▶ May-December 2017 (Stub Year 17)
 - ▶ January-December 2018 (CY18)
- ▶ Confirm that underspend from a particular SECA Grant cycle will be carried forward to the next full SECA Grant cycle available

WHERE ARE WE GOING? JANUARY 2018

- ▶ Stakeholder input
 - ▶ Grant applicants
 - ▶ Ad hoc community group formed specifically to discuss the future of SECA
 - ▶ Non-profit arm of Naperville Area Chamber of Commerce
 - ▶ Members of City Council
- ▶ Themes were identified from all meetings
- ▶ Distilled into four recommendations

FEBRUARY 2018 - RECOMMENDATIONS


- ▶ Create objective criteria and an associated point system to score applications
- ▶ Maintain the diversity of the SECA Grant Fund program awards
- ▶ Reinstate the 2% annual escalator beginning in CY19
- ▶ Eliminate the Legacy Events category and return Ribfest and the Last Fling to the Special Event category to receive the same funding and logistic scrutiny as all other events

RECOMMENDATION #1

- ▶ Create objective criteria and an associated point system to score applications
 - ▶ Post-event metrics currently in place
 - ▶ Clear understanding of what is required for a quality submission and areas to focus on to increase potential award amount
 - ▶ Run concurrently with the CY19 application cycle with a CY20 implementation
- ▶ Council consensus


RECOMMENDATION #2

- ▶ Maintain the diversity of the SECA Grant Fund program awards
 - ▶ Funding for cultural experiences and other celebrations will decrease without continuous evaluation of special event costs
 - ▶ Stakeholder consensus is to stay true to SECA mission and encourage a varied set of applications
- ▶ Council consensus




RECOMMENDATION #3

- ▶ Reinstate the 2% annual escalator




RECOMMENDATION #4

- ▶ Council consensus




RIBFEST AND LAST FLING CATEGORIZED AS “CITY OBLIGATIONS”

- ▶ 26% of annual SECA funding available for more than 60 applicants
- ▶ 74% of annual SECA funding considered non-discretionary and outside Commission review




