Dear TAB Board Members,

I hope this letter finds you in good health and high spirits. I am writing to express my deep concerns and objections regarding the proposed installation of sidewalks in front of my house. As a senior citizen and long-term resident of this community, I feel it is crucial to address the significant negative impacts this project will have on my property, quality of life, and the overall appeal of our neighborhood.

Firstly, the removal of the 50-year-old maple, elm, and magnolia trees that stand majestically on my property is distressing. These beautiful trees, with their vibrant foliage and unique characteristics, hold great sentimental value and significantly contribute to the curb appeal and character of our community. Their loss would not only result in the removal of natural beauty but also negatively impact property values in the neighborhood. Regarding the completion of the sidewalk on the east side of the 300 block of South Loomis St: While I support adding additional sidewalk, I DO NOT support the removal of trees that would be necessary at the top of the street, 304 S Loomis St, at the intersection of Loomis & Highland. The mature trees are located too close to the curb to allow the sidewalk to be installed there without removing so much of the roots that the trees would die. There is not enough space to place the sidewalk between the house and the trees. I would suggest that the sidewalk be completed from petitioner's house, 336 S Loomis St, south to Porter, as her main concern is that going to school is unsafe for her children. This would allow her family to walk to Porter and Loomis and cross at the intersection, which would make her feel safer. If the families north of 336 agree, it could be extended north through their properties, too., ending at the edge of 304 S Loomis St. I know the family at 304 is against harming the trees, as am I.

Too many mature trees have been removed for new houses and road improvements in our neighborhood. Losing the trees at the top of our hill would be felt by everyone, as the smaller ornamental maple trees along NCC's parking lot across the street are dying and will be removed soon. This would leave that corner, and Julie & Irv's house, entirely exposed and unshaded. Studies have shown that mature trees increase the value and aesthetics of neighborhoods and improve the well-being of residents. Mature trees also absorb more carbon than new plantings. I implore you to please amend the proposed sidewalk addition to South Loomis Street to *exclude* extending the sidewalk through the property at 304 S Loomis St.
