

ORDINANCE NO. 22 - _____

**AN ORDINANCE TEMPORARILY AMENDING THE NAPERVILLE
TRAFFIC SCHEDULE MANUAL TO REGULATE PARKING AND
A LOADING ZONE ON THE WEST SIDE OF WASHINGTON
STREET BETWEEN JEFFERSON AVENUE AND JACKSON
AVENUE FROM
WEDNESDAY, MARCH 16, 2022, TO THURSDAY, JUNE 16, 2022**

Recitals

1. **WHEREAS** the City of Naperville is a home rule unit of local government under the laws and Constitution of the State of Illinois; and
2. **WHEREAS**, the City of Naperville has the authority, and as set forth herein, does hereby establish regulations to provide a fair and efficient method for operating its municipal owned parking lots; and
3. **WHEREAS**, the City of Naperville, DuPage and Will Counties, Illinois (“City”), is a home rule unit of government and, pursuant to the provisions of Article VII, Section 6(a) of the Illinois Constitution, may exercise any power and perform any function pertaining to its government and affairs.
4. **WHEREAS**, the City Council has determined that this temporary parking and loading regulation is necessary to support businesses within the Downtown streetscape construction area.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority, as follows:

SECTION 1: The foregoing Recitals are hereby incorporated in this Section 1 as though fully set forth herein.

SECTION 2: Section VIIH, Miscellaneous – Limited Parking, of the Naperville Traffic Schedule Manual is hereby temporarily amended from 8:30 a.m. on Wednesday, March 16, 2022, to 4:00 p.m. on Thursday, June 16, 2022, to include the following underlined language and delete the following stricken language:

SECTION 3: Section XIII, Loading Zones of the Naperville Traffic Schedule Manual is hereby temporarily amended from 8:30 a.m. on March 16, 2022, to 4:00 p.m. on June 16, 2022, by adding the underlined language and deleting the stricken language as follows:

SECTION 4: If any section, paragraph, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision, shall not affect any of the remaining provisions of this Ordinance or any other City ordinance, resolution, or provision of the Naperville Municipal Code.

SECTION 5: That this Ordinance shall be in full force and effect after its passage and approval as provided by law.
