Parcel 1

THE WESTERLY 384.86 FEET, AS MEASURED AT RIGHT ANGLES TO AND PARALLEL WITH THE WEST LINE THEREOF OF THE FOLLOWING DESCRIBED PROPERTY, THAT PART OF THE NORTHWEST QUARTER OF SECTION 15. ALSO EXCEPTING THAT PART OF THE NORTHWEST QUARTER OF SECTION 15 TOWNSHIP 38 NORTH, RANGE 9 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS, COMMENCING AT THE INTERSECTION OF THE CENTERLINE OF NORTH AURORA ROAD, PURSUANT TO CONDEMNATION CASE 80E0-23), WITH THE WEST LINE OF SAID NORTHWEST QUARTER OF SECTION 15 AND RUNNING THENCE SOUTHEASTERLY ALONG THE CENTERLINE OF SAID NORTH AURORA ROAD 129.65 FEET, THENCE SOUTHWESTERLY AT RIGHT ANGLES TO THE LAST DESCRIBED COURSE 33.00 FEET TO THE POINT OF BEGINNING, SAID POINT BEING ON THE SOUTH LINE OF SAID NORTH AURORA ROAD: THENCE SOUTH 78 DEGREES 20 MINUTES 19 SECONOS EAST, ALONG SAID SOUTH LINE 20.00 FEET: THENCE SOUTH 79 DEGREES 54 MINUTES 30 SECONDS WEST, 37.15 FEET, TO A SOUTHERLY LINE OF SAID CONDEMNATION: THENCE NORTH 58 DEGREES 09 MINUTES 20 SECONDS EAST, 20.00 FEET, MORE OR LESS, TO THE POINT OF BEGINNING. THAT PART OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 38 NORTH RANGE 9 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS:
