ORDINANCE NO. 17 - \_\_\_\_\_

**AN ORDINANCE REZONING THE PROPERTY LOCATED AT  
830 PARKSIDE ROAD TO  
R1A (LOW DENSITY SINGLE-FAMILY RESIDENCE DISTRICT)**

**WHEREAS**, Brian Columbus ("Petitioner") has petitioned the City of Naperville for the rezoning of real property located at 830 Parkside Road, legally described on **Exhibit A** and depicted on **Exhibit B** ("Subject Property") to R1A (Low Density Single-Family Residence District) upon annexation; and

**WHEREAS**, the Subject Property is presently zoned R4 in unincorporated DuPage County and is improved with a single-family residence; and

**WHEREAS**, on June 7, 2017 the Planning and Zoning Commission conducted a public hearing to consider the rezoning request and recommended approval of PZC 17-1-030; and

**WHEREAS**, the requested rezoning meets the Standards for Rezoning as provided in **Exhibit C** attached hereto; and

**WHEREAS**, the City Council of the City of Naperville has determined that the Petitioner's request should be granted as provided herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:**

**SECTION 1:** The foregoing recitals are incorporated as though fully set forth here. All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

**SECTION 2:** The Subject Property, legally described on **Exhibit A** and depicted on **Exhibit B**, is hereby rezoned to R1A (Low Density Single-Family Residence District) in the City of Naperville.

**SECTION 3:** The Zoning Map of the City of Naperville is hereby amended in accordance with this Ordinance.

**SECTION 4:** This Ordinance is subject to all conditions and requirements set forth in the Naperville Municipal Code, as amended from time to time.

**SECTION 5:** The City Clerk is authorized and directed to record this Ordinance with the DuPage County Recorder.

**SECTION 6:** This Ordinance shall be in full force and effect upon its passage and approval.
