- 1. Naper North Property, LLC is the owner of the property within the City of Naperville located on South Washington Street, and having Parcel Index Number (PIN) 08-19-318-002 (referenced herein as "Commercial Property").
- 2. As Environmental Engineer contracted with Naper North Property, LLC, I have been authorized to give the Notice described herein and to execute this Affidavit.
- 3. Naper North Property, LLC is seeking issuance of a No Further Remediation ("NFR") Letter from the Illinois Environmental Protection Agency ("IEPA") as to the Commercial Property.
- 4.
