## ORDINANCE NO. 21-

## AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE CITY OF NAPERVILLE FOR THE YEAR COMMENCING JANUARY 1, 2022 AND ENDING DECEMBER 31, 2022

WHEREAS, the City of Naperville reviewed its proposed Annual Budget during workshops held on October 25, 2021, November 8, 2021 and November 22, 2021 and made said proposed Annual Budget available for public inspection before those dates; and

WHEREAS, the City of Naperville has caused the publication of a notice of a public hearing on the proposed Annual Budget in the Naperville Sun, a newspaper of general circulation in the municipality on the 28th day of November 2021; and

WHEREAS, the City Council of the City of Naperville held a public hearing on December 7, 2021 to consider said Annual Budget, said notice and hearing conforming in all respects, in both manner and form, with the statutes of the State of Illinois and the ordinances of the City of Naperville;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority, as follows:

**SECTION 1**: The budget totaling \$540,578,892 is hereby adopted as the Annual Budget for the City of Naperville for the year commencing January 1, 2022 and ending

December 31, 2022.

**SECTION 2**: As part of the Annual Budget, the Revenue and Expenditures Annual

Summary is attached to this Ordinance as **Exhibit A** and the Revenue and Expenditures

Summary by Fund and Type is attached to this Ordinance as **Exhibit B**.

**SECTION 3**: The adoption of the foregoing Annual Budget shall be in lieu of the

Appropriation Ordinance required by the Illinois Municipal Code, 65 ILCS 5/8-2-9 and this

Budget Ordinance is adopted pursuant to procedures set forth in the Illinois Municipal

Code at 65 ILCS 5/8- 2-9.1 et seq.

**SECTION 4**: If any section, subdivision or sentence of this Ordinance shall for any

reason be held invalid or unconstitutional, such decision shall not affect the validity of the

remaining portion and provisions of this Ordinance.

**SECTION 5**: The City Clerk is hereby authorized and directed to publish this

Ordinance in pamphlet form and this Ordinance shall be in full force and effect from and

after its passage, approval, and publication as provided by law.
