

ORDINANCE NO. 017 - _____

**AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR
THE FRIENDS OF LITTLE FRIENDS ELECTRIC PARADE ON
DECEMBER 2, 2017**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

SECTION 1: Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the Hometown Holidays Parade on Saturday, December 2, 2017 by adding the underlined language as follows:

Street	Area of Restriction	Side
<u>Main Street</u>	<u>From Jackson Avenue to Van Buren Avenue (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Jackson Avenue</u>	<u>From West Street to Main Street (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Webster Street</u>	<u>From Jackson Avenue to 250' North of Jackson Avenue (2:00pm – 8:30pm)</u>	<u>Both</u>

SECTION 2: Section VIA, No Parking Zones, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the Hometown Holidays Parade on Saturday, December 2, 2017 by adding the underlined language as follows:

<u>Jackson Avenue</u>	<u>From West Street to Main Street (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Main Street</u>	<u>From Jackson Avenue to Van Buren Avenue (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Jefferson Avenue</u>	<u>From Jefferson Street 120' West of Main Street to 120' East of Main Street (5:00pm – 8:30pm)</u>	<u>Both</u>

<u>Van Buren Avenue</u>	<u>From Washington Street to Webster Street (6:00pm – 8:30pm)</u>	<u>Both</u>
<u>Webster Street</u>	<u>From Jackson Avenue to 250' North of Jackson Avenue (2:00pm – 8:30pm)</u>	<u>Both</u>
<u>Main Street</u>	<u>From Benton Avenue to Van Buren Avenue (6:00pm – 8:30pm)</u>	<u>Both</u>
<u>Jefferson Avenue</u>	<u>From Webster Street to Washington Street (6:00pm – 8:30pm)</u>	<u>Both</u>

SECTION 3: Section XXVIA, Traffic Prohibited Streets, of the Naperville Traffic Schedule Manual is hereby temporarily amended for the Hometown Holidays Parade on Saturday, December 2, 2017, by adding the underlined language as follows:

<u>Main Street</u>	<u>From Benton Avenue to Van Buren Avenue (6:00pm – 8:30pm)</u>	<u>Both</u>
<u>Main Street</u>	<u>From Van Buren Avenue to Jackson Avenue (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Van Buren Avenue</u>	<u>From Washington Street to Webster Street 6:00pm – 8:30pm)</u>	<u>Both</u>
<u>Jefferson Avenue</u>	<u>From Webster Street to Washington Street (6:00pm – 8:30pm)</u>	<u>Both</u>
<u>Jackson Avenue</u>	<u>From West Street to Main Street (4:30pm – 8:30pm)</u>	<u>Both</u>
<u>Webster Street</u>	<u>From Jackson Avenue to 250' North of Jackson Avenue (2:00pm – 8:30pm)</u>	<u>Both</u>
