There are in my opinion three large trees worth saving, the Green Ash in the front of the house in the parkway is Ok for now because the City has been treating it, the two stem Bur Oak tree near the NW corner of the house in the parkway is worth saving and so is the large Walnut tree by the alley on private property. Unfortunately the two large Norway maples in the parkway along the Franklin Av side are in poor condition and should be removed in my opinion. I love trees but these are in need of removal whether anything is done with the house or not.
