

ORDINANCE NO. 25 - ____

**AN ORDINANCE AMENDING THE NAPERVILLE TRAFFIC
SCHEDULE REGARDING
PARKING RESTRICTIONS ON MAIN ST.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, ILLINOIS, DuPAGE AND WILL COUNTIES, in exercise of its home rule authority as follows:

SECTION 1: Section VIIC-2, Two-Hour Limited Parking 6:00 a.m. – 6:00 p.m. Monday Through Saturday, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
MAIN ST	From a point 50' south of Van Buren Ave to a point 150' south of Van Buren	East	92-210
MAIN ST	From a point 48' south of Van Buren Ave to a point 247' south of Van Buren Ave	West	92-210 05-206
MAIN ST	From a point 117' north of Jefferson Ave to a point 46' north of Jefferson Ave	West	92-210 05-206
MAIN ST	From a point 160' north of Jefferson Ave	East	94-17

SECTION 2: Section VIIG, Fifteen – Minute Limited Parking Official Business Only (in any one-hour period), of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
MAIN ST	From a point 63' north of Jefferson Ave to a point 85' north of Jefferson Ave (2 angled stalls, includes 1 compact stall	East	94-17

SECTION 3: Section XIII, Loading Zone, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
MAIN ST	From a point 47' north of Jefferson Ave to a point 105' north of Jefferson Ave (15 minute passenger vehicles/30 minute commercial vehicles)	West	07-112
MAIN ST	From a point 55' south of Van Buren Ave to a point 105' south of Van Buren Ave (15 minute passenger vehicle/30 minute commercial vehicles)	East	07-112

SECTION 4 : Section VIIC-2, Two Hour Limited Parking 6:00 a.m. – 6:00 p.m. Monday

Through Saturday, of the Naperville Traffic Schedule Manual is hereby amended by adding the underlined language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
<u>MAIN ST</u>	<u>From a point 60' south of the centerline of Van Buren Ave to a point 145' south of the centerline of Van Buren Ave</u>	<u>East</u>	
<u>MAIN ST</u>	<u>From a point 90' south of the centerline of Van Buren Ave to a point 250' south of the centerline of Van Buren Ave</u>	<u>West</u>	
<u>MAIN ST</u>	<u>From a point 155' north of the centerline of Van Buren Ave to a point 55' north of the centerline of Van Buren Ave</u>	<u>East</u>	

SECTION 5 : Section VIIG, Fifteen – Minute Limited Parking Official Business Only (in any one-hour period), of the Naperville Traffic Schedule Manual is hereby amended by adding the underline language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
<u>MAIN ST</u>	<u>From a point 115' north of the centerline of Jefferson Ave to a point 70' north of the centerline of Jefferson Ave</u>	<u>West</u>	

SECTION 6: Section XIII, Loading Zone, of the Naperville Traffic Schedule Manual is

hereby amended by deleting the stricken language as follows:

<u>Street</u>	<u>Area of Restriction</u>	<u>Side</u>	<u>Ord. #</u>
<u>MAIN ST</u>	<u>From a point 50' south of the centerline of Van Buren Ave to a point 90' south of the centerline of Van Buren Ave</u>	<u>West</u>	

SECTION 7: This Ordinance shall be in full force and effect after its passage and approval and after the proper signage has been installed.
