**AN ORDINANCE GRANTING A
TEMPORARY USE TO PERMIT THE ROTARY CLUB OF NAPERVILLE SUNRISE TO
PLACE A NAPER LIGHTS SPONSOR VEHICLE AND ASSOCIATED SIGNAGE AT
141 AURORA AVENUE**

WHEREAS, The Rotary Club of Naperville Sunrise ("Petitioner"), has petitioned the City of Naperville for approval of a temporary use to allow Gerald Subaru to display a dealer vehicle and associated sponsor signage on the property located at 141 Aurora Avenue, Naperville, Illinois ("Subject Property"), legally described on **Exhibit A**, from November 14, 2020 through January 9, 2020; and

WHEREAS, the Owner of the Subject Property, Marquette Companies, has consented to the requested temporary use; and

WHEREAS, the Subject Property is currently zoned TU (Transitional Use); and

WHEREAS, the proposed dealer vehicle signage and off-premise advertising are prohibited per Section 6-16-3 (Prohibited Signs); and

WHEREAS, pursuant to Section 6-2-11 (Temporary Buildings, Structures and Uses of Land), the City Council has the authority to grant the temporary use of a building, structure, or use of land that does not conform to the regulations prescribed in Title 6 for the zoning district in which it is located.

WHEREAS, the City Council has determined that the temporary use should be granted as requested by The Rotary Club of Naperville Sunrise.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:

SECTION 1: The foregoing recitals are incorporated as though fully set forth here. All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

SECTION 2: A temporary use to allow Gerald Subaru to display a dealer vehicle and associated sponsor signage on the Subject Property, as legally described on **Exhibit A**, is hereby granted from November 14, 2020 through January 9, 2021.

SECTION 3: This Ordinance is subject to all conditions and requirements set forth in the Naperville Municipal Code, as amended from time to time.

SECTION 4: The City Clerk is authorized and direct to record this Ordinance with the DuPage County Recorder.

SECTION 5: This Ordinance shall be in full force and effect upon its passage and approval.
