Smith explains that in 2015, a planning section in the code was updated to include the need for new multi-family developments to have .25 guest spaces per unit.

Laird asks if this impacts multi-family units only.

Smith confirms.

Nair asks for a summary of the changes in the overnight parking program update.

Smith gives an explanation of the changes.

Melaniphy states that it looks like we are giving staff flexibility to be able to work with specific communities on the program.
