

ORDINANCE NO. 21 - _____

AN ORDINANCE AMENDING CHAPTER 12 (DISCLOSURE OF BENEFICIARIES) OF TITLE 1 (ADMINISTRATIVE) OF THE NAPERVILLE MUNICIPAL CODE TO MODIFY REQUIREMENTS FOR THE DISCLOSURE OF BENEFICIARIES

RECITALS

1. **WHEREAS**, Chapter 12 (Disclosure of Beneficiaries) of Title 1 (Administrative) of the Naperville Municipal Code requires that persons, firms, corporations and entities seeking benefit of the City provide a written disclosure of interest statement; and
2. **WHEREAS**, said disclosure of interest statements shall include the names and addresses of all persons with ownership or other financial interest in land trusts, corporations, partnerships, joint ventures or other entities; and
3. **WHEREAS**, Section 1-12-5 of the Naperville Municipal Code provide for exceptions to the disclosure requirements for certain contracts, permits, licenses, approvals or benefits; and
4. **WHEREAS**, the City of Naperville finds that the disclosure requirements for building permits for small improvements valued under \$100,000, and do not otherwise require Naperville City Council approval of a variance to the building code, are burdensome to the applicant and unnecessary for the issuance of the permit; and
5. **WHEREAS**, the City of Naperville desires to amend Section 1-12-5 of the Naperville Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:

SECTION 1: The foregoing Recitals are hereby incorporated in this Section 1 as though fully set forth herein.

SECTION 2: Chapter 12 of Article 1 of the Naperville Municipal Code is hereby amended by adding the underlined language and removing the strikethrough text as follows:
