- Written comments received after 5 p.m. the day before the meeting will be added to the case file.

Commissioner King made a motion, seconded by Commissioner Robbins to adopt the findings of fact as presented by the petitioner and approve PZC 24-1-069, a variance from Section 6-2-10:5 of the Naperville Municipal Code to permit a pergola to remain in the rear yard, allowing approximately 30.5% of the required rear yard to be occupied at 247 Claremont Dr.
