#### PUBLIC COMMENT:

##### **WRITTEN COMMENT ONLY**

Marilyn L Schweitzer (Naperville) - The proposed 2026 budget shows the City's cost for NCC Park to \$3.2 million in 2026. This is 50% of the projected budget for the entire South Extension/Hillside Gateway which is being deferred until 2027. The proposed NCC Park at 430 S Washington is owned by North Central College and is only .4 acres. The 2025 CIP shows the cost for the park to be \$1.45 million, roughly the same as a state grant is contributing. Now in 2026 it seems the cost has doubled, but I can find no new plans. (The state it seems is still willing to contribute \$1.1 million towards it though.) Please explain: • Why the cost has doubled on a plan that is only on .4 acres. • Whether NCC has been approached to pay for all or part of the amount above the \$1.1 million state grant. • What branding or benefit the Riverwalk will gain by paying for the development. (As near as I can tell from the plans, the branding is all for the college. Even the 2026 CIP in the City Budget calls it NCC Park now rather than 430 S Washington.) • What are the legal agreements between the City, Park District, and NCC for the development and maintenance of this property owned by NCC. Commissioner Hynes reviewed the following project updates and photos that were included with the agenda packet:

**Eagle Street Gateway:** Construction continues on the Eagle Street Gateway project. Various retaining walls, staircase components, and landscaping have been installed over the past few weeks. Completion is expected in October.

**Fredenhagen Park Fountain Repairs:** The contractor has installed the conduit and Park District staff have restored the brick pavers. The next step will be the application of the new waterproof liner pending appropriate weather conditions. The projects is expected to be completed in October with activation of the fountain to follow.

**Fredenhagen Park Miscellaneous Repairs:** The cleaning and staining work on various features within Fredenhagen Park is complete.

**Grand Pavilion Questionnaire:** A questionnaire regarding potential future improvements to the Grand Pavilion is now available online through the City's website. The survey results will be shared with the Riverwalk Commission at a future meeting and help guide the scope of this project.

Commissioner Shields provided background on the Naperville ArtForum and the change in scope to the Spring Renewal Lightscape project, which will now be a project in downtown Naperville and not on the Riverwalk. Naperville ArtForum is requesting the Riverwalk Commission's approval for the Light Anemones at Paddleboat Quarry installation which will be proposed for a two-to-three-week period in October of 2026. Commissioner Shields thanked Commissioner Wohlt for his suggestions that were shared at last week's PDC Committee meeting and advised that Shannon Greene Robb would be willing to include "Naperville Riverwalk" in the event marketing and would collaborate with the Commission on a suggested walking path. The PDC Committee recommended approval at the September 30th meeting and it was noted that the Naperville Park Board has not yet voted on this proposal.

Commissioner Picco reported on the following highlights from the Park District report included in the agenda packet.

Staff has been watering due to the draught conditions with only .58” of rain being measured for the last month, as of September 25th.

New plants were planted behind the Horse Trough fountain area, which were generously funded by the Naperville Riverwalk Foundation. 1,100 native plugs were added to the shoreline near the metal bridge and were generously donated by a donor through the Conservation Foundation.

The contractor at the Fredenhagen Park fountain needed to move a large number of pavers for installation of conduit. Park District staff backfilled the areas and replaced the pavers.

Some of the summer annuals have been removed and replaced with fall mums and kale. The remainder of the summer flowers will be removed as they fade

for the season.

The Park District partnered with Max's Mission to create four murals adjacent to the Rothermel Family Skate Facility at Centennial Park. The ribbon cutting was held last week with over 150 people in attendance. Photos were included in the report which is included in the agenda packet.

Upcoming events in October were also listed in the agenda packet and include the Naperville Half Marathon and 5k and the Naperville Healing Field of Honor.

#### **6. Donor Recognition - Rebecca DeLarme**

DeLarme reported that the Fall 2025 Legacy Gift order was submitted to the engraver. The Spring 2026 Legacy Gift order deadline is March 15th and currently consists of one 4" x 8" commemorative brick. Installation for the Fall order should occur in November. She thanked the Park District staff for reinstalling the donor pavers after the Exchange Club Memories Fountain repairs were complete, and advised that the Spring 2025 8" x 8" bricks will now be installed on October 9th at 8:00 a.m. Discussion followed on replacement bricks with DeLarme noting that worn/faded bricks are replaced each year if there is money remaining in the budget.
