

**ORDINANCE NO. 24-\_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 3 (BUSINESS AND LICENSE REGULATIONS),  
CHAPTER 3 (LIQUOR AND TOBACCO CONTROL),  
SECTION 11 (LIQUOR LICENSE AND PERMIT CLASSIFICATIONS) AND SECTION 12  
(ADDITIONAL LIQUOR LICENSE RESTRICTIONS)  
OF THE NAPERVILLE MUNICIPAL CODE**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers that:**

**SECTION 1:** Title 3 (Business and License Regulations), Chapter 3 (Liquor and Tobacco Control), Section 11 (Liquor License and Permit Classifications) of the Naperville Municipal Code is hereby amended by adding the underlined language as follows:

**3-3-11: LIQUOR LICENSE AND PERMIT CLASSIFICATIONS:**

The following are classes of liquor licenses and permits with an annual license and permit fee as indicated:

1. On-premises consumption liquor licenses:

3. Quantity Sales For On Premises Liquor Consumption: It shall be unlawful for a licensee, except for a Class B – Restaurant and Tavern licensee, to sell, give away or permit to be sold, served or given away for consumption on the licensed premises any serving containing more than twenty-four (24) fluid ounces of beer or cider, six (6) ounces of wine, or three (3) ounces of spirits except wine by the bottle or carafe.
