

**ORDINANCE NO. 22-\_\_\_\_\_**

**AN ORDINANCE  
APPROVING AN AMENDMENT OF THE CITY OF NAPERVILLE  
ANNUAL BUDGET FOR CALENDAR YEAR 2021**

**Recitals**

1. **WHEREAS**, on December 1, 2020, the City of Naperville passed Ordinance No. 20-129 approving an Annual Budget for the City of Naperville for Calendar Year 2021 commencing on January 1, 2021 and ending on December 31, 2021 (hereinafter also referred to as "Annual Budget") in the amount of \$502,423,551; and
2. **WHEREAS**, the City of Naperville Annual Budget shall show the specific fund from which each anticipated expenditure shall be made; and
3. **WHEREAS**, the City of Naperville is now amending its Annual Budget in order to transfer funds from the General Fund to the Naper Settlement Fund, thus increasing the total budget by \$1,000,000; and
4. **WHEREAS**, funds are available to effectuate said revision of the Annual Budget; and
5. **WHEREAS**, the amended Annual Budget totals \$503,423,551; and
6. **WHEREAS**, an amendment of the Annual Budget requires a two-thirds vote of the corporate authorities of the City of Naperville then serving.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority, as follows:**

**SECTION 1:** The foregoing Recitals are hereby incorporated in this Section 1 as though fully set forth herein.

**SECTION 2:** The Budget Summary for the amended City of Naperville Annual Budget for Calendar Year 2021 is attached hereto as Exhibit A. The Annual Budget for Calendar Year 2021 is hereby amended and the amended Annual Budget for Calendar Year 2021 of \$503,423,551 is hereby approved.

**SECTION 3:** If any section, paragraph, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Ordinance or any other City ordinance or resolution, or any provision of the Naperville Municipal Code.

**SECTION 4:** This Ordinance shall be in full force and effect upon its passage and approval.
