#### A. CALL TO ORDER:

Chair Erickson was not in attendance. Riverwalk Planning, Design and Construction (PDC) Committee Chair Shields called the February 11, 2026 Naperville Riverwalk Commission meeting to order at 8:15 a.m. The meeting was held in Meeting Room C at the Naperville Municipal Center located at 400 S. Eagle St., Naperville, IL.

#### E. OLD BUSINESS:

##### 1. Riverwalk Standard Paving Brick - Andy Hynes

Approve a recommendation to use the Stockholm brick paver on the Riverwalk path

Janette Erickson (Naperville) - Change Riverwalk Brick Standard: Stockholm Design -

First, I'm sorry I can't join you for the February Riverwalk Commission meeting and this important discussion. I would like to share my support for changing the

Riverwalk brick standard back to the original Stockholm design. (Otherwise known as the wavy brick design.). I believe it is as important to the Riverwalk brand as the iconic shepherd crook lights. Now that we know that a new Stockholm mold can be created and used to produce the bricks, I believe it is important to continue to utilize the original brick design. I also believe that, had we known a new mold could be produced with a relatively affordable cost, we would not have voted to change the brick standard. Please consider the importance of consistency to the Riverwalk brand. I hope you join me in supporting the change back to the original Stockholm brick design.

Commissioner Hynes reviewed the background on the Stockholm paver that had been in use since the Riverwalk was constructed in 1981. In June 2025, the Riverwalk Commission voted to change the brick paver as it was advised that the Stockholm mold was no longer available. Based on discussions at the December 2025 Riverwalk Commission meeting, City and Park District staff, Chair Erickson and Tim Ball (GRWA) met with Unilock representatives who explained that the mold for the Stockholm paver was over 20 years old, in poor condition, and was not compatible with their new machinery. They advised that a new mold could be made that would work with their current system. The cost for the mold is approximately \$36,000 to include manufacturing and shipping from Germany with a lead time of four months. With the estimated cost of the new mold being significantly less than previously anticipated and in order to maintain consistency with the current paver design, staff recommends purchasing the new mold.

Mike Farraday with Unilock provided answers to questions from the group that included the following: 1) the mold would be stored at Unilock; 2) Unilock would not run the mold for any other use (no one else is using at this time) and would notify the Riverwalk Commission if the request ever came up; 3) the new paver would be the exact size of the existing paver; and 4) the lifespan of the mold would be based on run cycles and could possibly last another 30 years.

Discussion followed on the approximate square footage needed for the 430 South Washington Street Project (2,000 sq ft) and the South Extension (16,000 sq ft). The Endura surface was explained which includes a larger dose of pigment in the top layer and endures better over time. The potential to seal new bricks or stain existing bricks and an increase in cost for the Stockholm pavers as opposed to a standard 4" x 8" Hollandstone paver was also discussed. The group expressed their appreciation to Farraday and Unilock, Chair Erickson, Commissioner Hynes and Tim Ball for working toward such a positive outcome.

**A motion to approve the recommendation to use the Stockholm brick paver on the Riverwalk path was made by Commissioner Sullivan and seconded by Commissioner Wohlt. The motion carried by the following vote:**

## 2. Mr. and Mrs. Naperville Statue - Tiffani Picco

Commissioner Picco discussed the plaque options included in the agenda packet for the Mr. and Mrs. Naperville statue. Adding a plaque to the front of the statue was approved at the January 14, 2026 Riverwalk Commission meeting.

The front face of the concrete base of the statue measures 9" tall by 48" wide. The Park District's plaque contact suggested a 5" tall plaque for the front face, leaving 2" at top and bottom once the plaque is secure to the face of the concrete. Of the two options shown, one measured 10" wide and the second measured 18" wide with larger letters. Commissioner Picco noted that the plaque would be similar to the existing plaque located on the back of the statue with a black background and gold lettering. Discussion followed on making the print larger, using an ampersand, and the order of the names which should read: Margaret and Harold Moser. Quotes should be included for "Mr. and Mrs. Naperville".

Commissioner Picco will bring this item back to next month's meeting for final approval before ordering the plaque.
